Planning Commission Approves Housing Element Amendments

Last night, the Huntington Beach Planning Commission approved the Housing Element amendments with a 6-1 vote (Garcia-no). The City Council will review and vote on this item at a upcoming meeting next month.

During the past several months, the Huntington Beach City Council had expressed an interest in obtaining State SB2 funds for use towards the City's homelessness response efforts. After review, it was identified that to comply with State regulations, the City's 5th Cycle Housing Element would have to be updated in order to access SB2 funding. Given those factors, on November 4th, the City Council directed that staff prepare the requisite Housing Element amendments and submit the proposed changes to HCD for a required 60-day review.

The City received formal notification from the State Department of Housing and Community Development (HCD) last week, stating that our draft Housing Element Amendment <u>does</u> in fact comply with the State's 5th Cycle Housing Element law. This determination means that if the City adopts the proposed Housing Element amendments, along with all the associated changes for the Beach Edinger Corridor Specific Plan (BECSP), HCD will certify our 5th Cycle Housing Element. The following amendments are included as part of our proposed 5th Cycle Housing Element update:

- Establish an Affordable Housing Overlay on six sites located within the BECSP area (the seventh site we initially looked at on CalTrans property was excluded by the State from this review)
- On the six sites identified in the Affordable Housing Overlay, all of the current regulations associated with the BECSP would remain in place, except under the following circumstances:
 - For the six sites, a developer that proposes a housing project with at least 20 percent of its units set aside for extremely low/very low / low income affordable housing would qualify for a slightly different development review process, as follows:
 - No conditional use permit needed
 - No requirement for inclusion of a mixed-use project component
 - Studio / One bedroom units would be required to provide one parking space per bedroom, instead of two parking spaces per bedroom (a standard that is consistent with our current citywide multifamily residential standards)

City Required to Abide by Senate Bill 54

This past Friday, the California State Appellate Court overturned an Orange County Superior Court ruling, thereby requiring that Huntington Beach (and all Charter Cities) abide by the provisions of SB 54 known as the California Values Act of 2017. The City Council will meet in closed session to discuss next steps in January 2020.

Update: Latest Homelessness Response

The City's planned Study Session for Monday, January 13, was cancelled due to the Governor Newsom's recent Executive Order. The City plans on moving forward with a review of its homeless response options with the City Council soon. However, staff needs a bit more time to assess how the new tools offered up by the State might impact our overall homeless response.

In particular, as part of Executive Order N-23-20 instituted by the Governor (https://www.gov.ca.gov/wp-content/uploads/2020/01/EO-N-23-20-Homelessness-Crisis-01.08.2020.pdf), it has been identified that State owned properties and equipment could be made available to cities and counties to address homelessness related issues. We plan to revisit this soon and will keep you updated of our progress.

SENIOR CENTER NEWS

Project V Grant Application Submitted; Pilot Program for On-Demand Ride Sharing Program (with Lyft or Uber) Being Developed

During the past few weeks, City staff has been working with representatives from OCTA on developing the City's Project V grant application, which is aimed at developing an alternative public transportation pilot program here in Huntington Beach. If the City is successful, it intends to utilize the $\sim\!\!5500\mathrm{K}$ / year grant to institute an initial transit test program that would involve the following general components:


- Establish the pilot program to occur in the Southeast area of town (bordered to the north by Adams Avenue, to the south by PCH, to the west by Beach Boulevard, and to the east by the City's boundary).
- For residential areas located in the identified service area, we would establish a ride-sharing program with a TNC provider (like Lyft or Uber) so that residents could get a ride to the City's Downtown area for a fixed cost of \$2.00 / ride.
- In addition, any return trip home from Downtown would also cost a fixed \$2.00 / ride.

The proposed program parameters are general in nature, and the way that Project V grant funds work, the City will have the opportunity to iteratively make program adjustments, should the City be successful in receiving the grant funds.

The City has submitted its grant application to OCTA, and should know in the next few months whether or not we are successful in receiving the funds.

Circuit Transportation Program for Downtown Being Discussed

To enhance the HB Downtown visitor experience, the City has been working to develop a possible partnership with a company called Circuit. Given the current layout of Downtown, and the challenges associated with getting from Pacific City to 5th Street, the City has been looking at the possibility of working with Circuit to facilitate free on-demand shuttle rides in our downtown district.

Circuit operates similarly to Lyft / Uber, where users download a free application on their smartphone, and then use the app to call for a ride. To date, the City has discussed integrating Circuit on a pilot trial basis for this upcoming summer season, and to fund the program, we've spoken to Visit HB and the Downtown BID about asking the resorts to help fund the program. Everyone seems enthused about the option and the City will be further developing the concept in the coming weeks.



Library News

We thought that you might be interested in hearing that during the month of December, the Library circulated over 6,300 eBooks and eAudio books! That averages out to over 200 eBooks and eAudio books checked out per day!

In addition, some other interesting operating statistics from the Library are as follows: Number of Visitors at Central Library (Week of December 30 to January 5)

• 7,855 total people - That's more than 1120 people served every single day (this doesn't take into consideration that the Library facility was closed on 1/1/20).

WIFI Usage at Central Library (Week of December 30 – January 5)

• 2,954 total unique clients during the seven-day period - That's more than 920 clients who signed onto the Library's WIFI service every day.



Is Your Business Compliant with SB 205?

New Requirements for Industrial/Manufacturing Businesses

On October 2, 2019, Governor Newsome signed into law Senate Bill 205 which addresses the pervasive issue of industrial facilities that remain unregulated by California's clean water laws. In California, most industrial facilities are subject to the State's Industrial General Permit (IGP) and must comply with the Industrial General Permit's stringent requirements in order to protect our communities and waterways from toxic metals and pollutants. Despite this, thousands of industrial facilities remain unpermitted throughout the state – meaning that toxic pollution washes from these unregulated oil refineries, landfills, manufacturing plants, and auto salvage yards and into our waterways every time it rains.

To address this issue, SB 205 requires all municipalities that issue business licenses to verify that applicants for all new business licenses and renewals are compliant with the State's Industrial General Permit as applicable effective January 1, 2020. Applicability is determined by the Standard Industrial Classification (SIC) Code, as identified by the business owner when applying for a new business license or when renewing. The businesses/industrial facilities subject to coverage and requirements of the State Industrial General Permit are as follows:

- 10xx-14xx (Oil and Gas Mining Facilities)
- 20xx-39xx (Manufacturing Facilities)
- 40xx-45xx, & 5171 (Transportation Facilities)
- 4211-4225 (Storage Facilities)
- 5015/5093 (Recycling Facilities)
- 5171 (Petroleum Bulk Stations)

Prior to applying for a business license or renewal of an existing business license, please verify that your SIC code is correct and matches the activity conducted at your facility (onsite activities only). If your business/facility falls into one of the SIC categories listed above, you must contact the State Water Board and obtain Industrial General Permit coverage or an exemption. A 90-day provisional license will be issued by the City allowing you to operate until you can provide evidence of compliance with the Industrial General Permit or an exemption to the permit. If you do not obtain coverage or an exemption, your provisional license will be rescinded.

NEW RECREATION MANAGEMENT SOFTWARE BEING DEVELOPED; NEW SYSTEM SET TO GO LIVE IN LATE JANUARY 2020

During the past few months, the Community Services Department has been working to transition the City's recreation management platform to a new system, called RecTrac 3.1.

The updated system will feature a newly redesigned (and mobile-friendly) user interface for both staff and customers, and will also include a new-and-improved camping reservation system for the Sunset Vista Campground. RecTrac 3.1 will be the first major update to the City's recreation system since 2014, and is expected to go live the week of January 27, 2020.

City Recieves Grant from OCTA

The City of Huntington Beach Community Services Department's Senior Center in Central Park was recently awarded a grant through the OCTA's Enhanced Mobility for Seniors and Disabled Grant (EMSD) program. The grant is valued at \$253,000.00 and will pay for three replacement vehicles for the transportation program. The grant also funds a new software program allowing drivers to utilize electronic tablets. The program currently provides approximately 200 one-way trips daily, Monday – Friday. The service is free. Huntington Beach residents 60 and older qualify for the program.

Huntington Beach Senior Services Transportation Program – Surf City Seniors on the Go! provides important transportation services for seniors and the frail/elderly who need special care and support. Senior transportation provides the ability to maintain health through regularly scheduled medical visits and maintaining a high quality of life through shopping trips and other points of interest including barber and beauty shops, veterinarian visits with pets and a host of other trips. With the continued growth of the 85+ population, current services remain challenging and it would be difficult to fill the need for persons with increasing health and mobility issues without updated vehicles.

Surf City Seniors on the Go! delivers passengers anywhere in Huntington Beach, also the Hoag campus in Newport Beach, Fountain Valley Hospital, surrounding physicians and the Social Security office. Over 50 volunteer drivers, alongside paid drivers, help make this unique crew a great success.

The Huntington Beach Senior Center in Central Park is dedicated to providing a growing number of services to promote Active Aging and Aging in Community. Funded by the City of Huntington Beach, additional support is provided by the Huntington Beach Council on Aging, Hoag Hospital, Orange Coast Memorial, OCTA's Senior Mobility Program, CDBG (HUD) and private donations.





High-quality Emergency Medical Care Is Making A Difference!


In early 2018, the Huntington Beach Fire Department championed enhancements to cardiac arrest protocols which were recently implemented by the Orange County Emergency Medical Services Agency (OCEMS) for all fire departments in the County. The enhancements to cardiopulmonary resuscitation (CPR) and cardiac arrest management were aimed at improving patient survival rates. Current statistics show that our efforts are really making a difference in our patient care!

- According to the American Heart Association, the national average survival rate (with a good neurological outcome) for out-of-hospital cardiac arrest is eight percent.
- However, cardiac arrest survival rates (with a good neurological outcome) over the past six months has been approximately 25 percent in Huntington Beach, which is three times the national average and double the survival rate we typically saw before the enhancements!

Since December 13, 2019, the HBFD also has new automatic chest compression devices (ACCD) in service, which are used when moving and transporting a cardiac arrest patient. These incredible devices will provide continuous high-quality chest compressions during the most difficult times to accomplish high-quality CPR, which will further help to improve the survival rates for our cardiac arrest patients.

The pictures below show Stryker's Lucas 3 ACCD and a lineup of the devices in their backpack cases. These ACCDs have now been placed on every fire engine in Huntington Beach; ready to make a difference in someone's life! Did you or someone in your family receive a new bicycle over the holiday season? If so, have you registered it at Project 529 yet? In the event your bike is ever stolen, you will want to report it immediately to the police department, but if you don't have the serial number or a photo of the bike, it makes it very difficult for us to track it. So when officers are on patrol and stop someone suspicious they think might have a stolen bicycle, we are unable to determine who the bike belongs to.

Project 529 helps us greatly with this, and it literally takes 10 minutes to register your bike. They even send you notifications about your registration anniversary to ensure you have not sold the bike or have any other changes that need to be made.


