We are pleased to see that the vast majority of the businesses approached, handled the situation appropriately and we sincerely thank those businesses throughout the City that make the effort to help reduce underage smoking.

The Huntington Beach Police Department will be conducting future sting operations related to underage sales of alcohol and tobacco.
