DETAILS:

On 3-17-10 at approximately 6:45 p.m. Abel Villareal was crossing northbound PCH at 7th St., in the City of Huntington Beach. As Villareal arrived on the north side of the street, he was confronted by four subjects driving westbound on PCH, in a silver Infinity. Villareal and subjects inside the vehicle got into a verbal altercation. The vehicle stopped and several subjects exited the car and physically confronted Villareal. During the confrontation, Villareal was stabbed several times and property was taken from him. The suspects re-entered their vehicle and fled westbound on PCH from 7th St. Huntington Beach Police Officers located the vehicle as it was traveling westbound approaching Warner Ave. Huntington Beach Officers attempted to initiate a stop of the vehicle. The vehicle fled from the Officers, northbound on Warner Ave. After a short pursuit the suspects' vehicle yielded to the Officers. All suspects' were taken into custody. The incident is still currently under investigation.
